RE: Notices for Termination of Agreements with RedSpeed Illinois, LLC,
regarding the Automated Traffic Law Enforcement System

Pursuant to the Village Board's approval of the Resolution Authorizing The Termination Of A Violation Processing Service Agreement And An Agreement Between RedSpeed Illinois, LLC, And The Village Of Lombard For An Automated Traffic Law Enforcement System, As Amended, we sent termination notices to RedSpeed Illinois, LLC, and its attorney, Martin S. Korey. In accordance with the Agreements, those notices were delivered to Federal Express for overnight delivery, prepaid, signature requested, marked for next day delivery, on Friday, September 17. Those notices were effective one business day later, or September 20, 2010. Therefore, the Agreements will terminate after November 18, 2010, based upon the sixty (60) days written notice provision.
