Re: Financial Assistance Program for Backyard Flooding Problems

Dear Mr. Rickard:

During the recently completed St. Charles Corridor Improvement Project, I was told by the Village Board and the Public Works Committee that no financial assistance was available to help offset the cost of hooking up an existing catch basin on my property to the village's sewer system.

Now I see that the village has created a program that would reimburse homeowners for half the cost of installing a village-approved drainage system. However, this new plan, which took effect January 20 of this year, is retroactive to Dec. 1 or about 6 weeks after work on my property was completed at a cost of \$1,680.00.

I will attend your committee's scheduled February 8 meeting to discuss this matter further.
