The Transportation and Safety Committee voted to endorse an Ordinance that would prohibit parking on the west side of Main Drive to eliminate observed emergency vehicle impasses on the narrow street.

### Ordinance to Modify Existing Parking Restrictions on Main Drive

The Public Works Department received a complaint from the Fire Department concerning vehicles being parked on both sides of Main Drive between Central Avenue and Main Street during evening and weekend high school events. Since the roadway is only 25 feet wide, the parked vehicles create an impasse for emergency vehicles.

A review of the Traffic Code revealed parking is prohibited on both sides of Main Drive during school hours, Monday through Friday, and on the east side of Main Drive between Central Avenue and Main Street for more than one hour between the hours of 6:00 am and 5:00 pm on any day except Sundays and holidays. These current restrictions do not prohibit parking at the times when the Fire Department is witnessing the impasse problem. The Transportation and Safety Committee discussed modifying the Traffic Code by exchanging the existing one hour limited parking restriction on the east of Main Drive with prohibiting parking at all times on the west (fire hydrant) side of Main Drive. A map demonstrating the recommended No Parking Zone is attached for your reference.

On January 10, 2012, the Transportation and Safety Committee voted to recommend the following modifications to the Traffic Code and to post the applicable signage once approved.

#### **SCHEDULE X – PARKING TIME LIMITED ON CERTAIN STREETS**

(b) In accordance with Section 10-13-10 and when signs are erected giving notice thereof, no person shall park a vehicle for a period of time exceeding one hour between the hours of 6:00 A.M. and 5:00 P.M. on any day except Sundays and holidays in any of the following places:

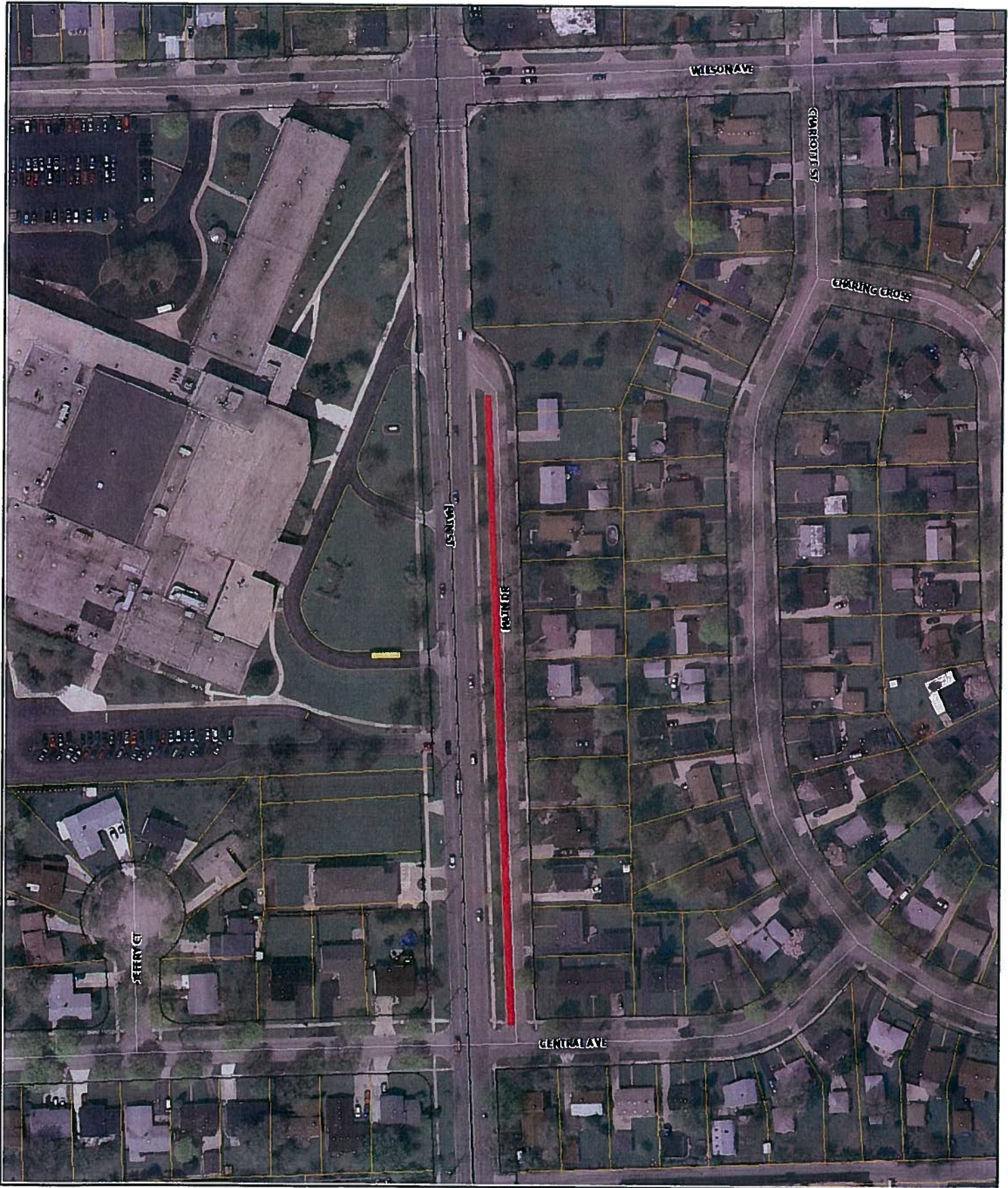

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule X(b) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (for a period of time not exceeding one hour between the hours of 6:00 a.m. and 5:00 p.m. on any day except Sundays and Holidays) be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Main Drive East side	Central Ave.	Main St.

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Main Drive. West side	Central Ave.	Main St.

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
