SUBJECT: **Text Amendment to Title XI, Chapter 121, Section 121.03A.(2)
Number of Public Passenger Licenses**

Village Code Title XI, Chapter 121, Section 121.03 states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

303 Taxi, LLC d/b/a 303 Taxi located at 5200 N. Otto Avenue, Chicago IL had a taxicab license to operate within the Village of Lombard through June 30, 2021. 303 Taxi has not responded to the Village nor have they paid the renewal fee after being advised by email and subsequently by letter on August 11, 2021 that their taxicab license expired and outlined the actions needed to renew their license.

Attached is an ordinance amending Title XI, Chapter 112, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from four (4) to three (3) to accommodate the non-renewal of the aforementioned licensee.

Staff is requesting a waiver of first reading in order to reflect the current number of public passenger licenses.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 121,
SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be three (3) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the voluntary non-renewal of the license by:

303 Taxi, LLC d/b/a 303 Taxi, 5200 N. Otto Avenue, Chicago IL 60656

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
