**SUBJECT: Amending Title 11, Chapter 112, Section 112.13(A)
Mariano's #543 - 345 W. Roosevelt Road**

The Village has received a request for a liquor license from Roundy's Illinois, LLC d/b/a Mariano's #543 located at 345 W. Roosevelt Road. Mariano's primary function is a grocery store establishment. They are requesting the ability to serve and consume alcohol onsite, either within the store or on their patio, as well as packaged sales of alcohol. Mariano's is currently under construction and anticipating an August opening.

As you will recall, a new Class "GGG" liquor license category was created and approved at the June 15, 2017 Village Board meeting. Roundy's Illinois, LLC d/b/a Mariano's #543 is requesting a license in that liquor classification.

The petitioner is requesting a waiver of first reading in order to accommodate their opening date.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "GGG" liquor license, contained therein, to read as follows:

Class "GGG" - 1

This increase in Class "GGG" liquor licenses reflects the issuance of a Class "GGG" liquor license to Roundy's Illinois, LLC d/b/a Mariano's #543 located at 345 W. Roosevelt Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
