**130059; Ordinance to Amend Parking Restrictions on Cortland Avenue**

Approximately one year ago, a new business opened on Cortland Avenue in the North Industrial Park and almost immediately approached the Village regarding the need for additional parking. At that time, Village staff requested that the business resolve their parking needs by approaching the other area businesses and asking permission to utilize adjacent property's unused off-street parking spaces. They were able to make some arrangements, but continue to have concerns regarding available parking. The business is still asking the Village for relief, such as removal of current on-street parking restrictions. The Police Department has been monitoring the situation and suggests a portion of Cortland Avenue could support additional on-street parking available for approximately 6-9 vehicles. Considering commercial vehicle ingress and egress ability for area businesses, time of day, and type of vehicles most likely to utilize on-street parking in this area, it was recommended to amend the current parking restrictions on the south side of Cortland Avenue to allow on-street parking of Non-Commercial Vehicles after 5:00 pm on weekdays and all day on weekends. Attached is a map of the area and identification of the proposed parking restrictions for your reference.

On February 4, 2013, the Transportation and Safety Committee voted to recommend the following modification to the Traffic Code.

**SCHEDULE VII – PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS**

In accordance with Section 10-13-1 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle upon any of the following streets or parts of streets:

Name of Street	From	To
<b>Remove:</b> Cortland Ave., south side	Ridge Ave.	Dead End
<b>Add:</b> Cortland Ave., south side	Lombard Rd.	A point 200 ft east of Lombard Rd.
<b>Add:</b> Cortland Ave., south side	Ridge Ave.	A point 40 ft west of Ridge Ave.
<b>Remove:</b> Cortland Ave., both sides	Ridge Ave.	Lombard Rd.
<b>Add:</b> Cortland Ave., north side	Ridge Ave.	Lombard Rd.

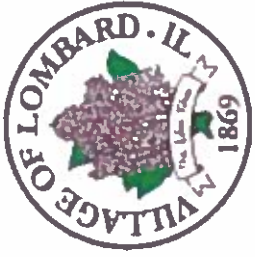

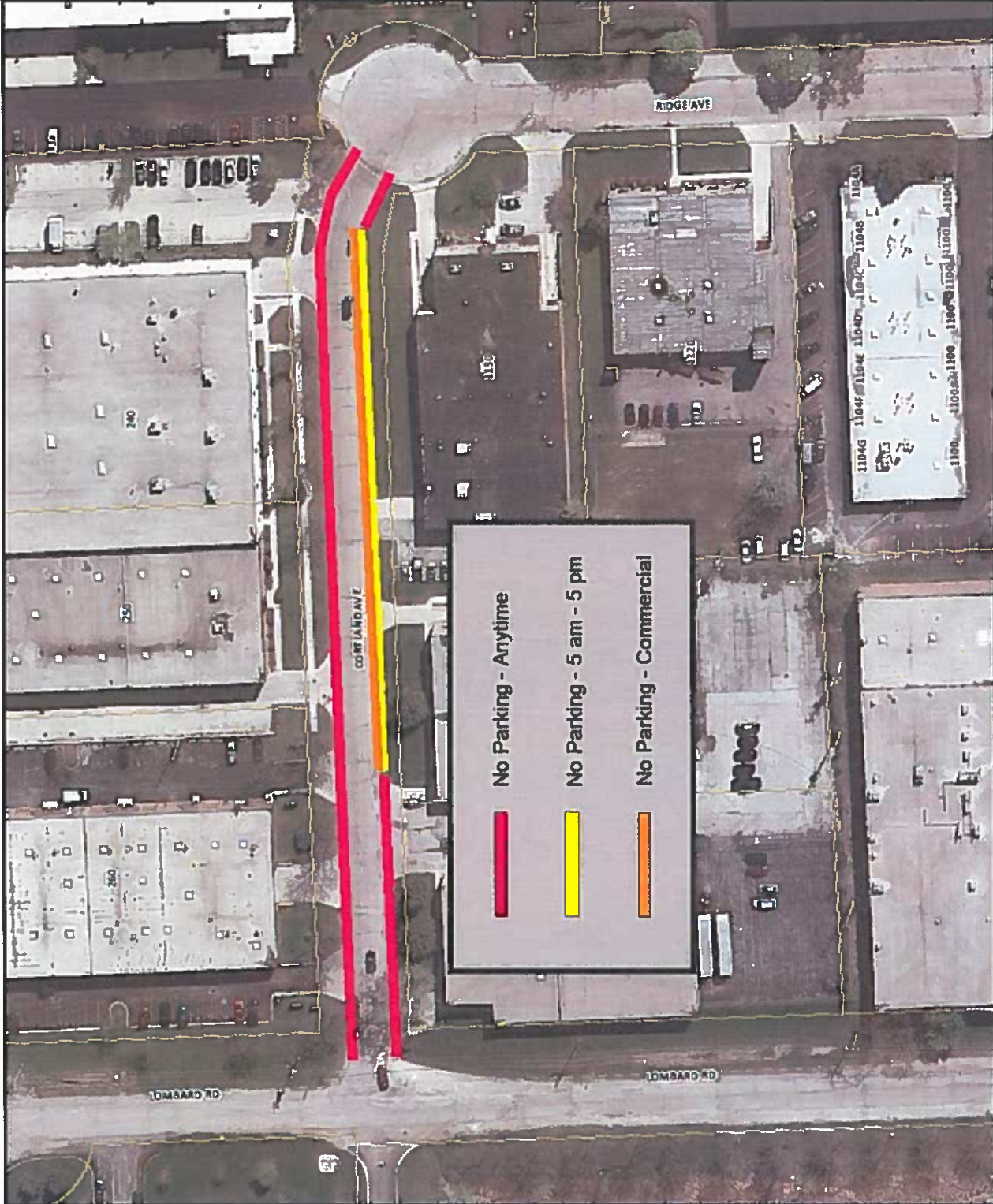

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS, be amended to remove the following hereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Cortland Ave., south side	Ridge Ave	Dead End
Cortland Ave., both sides	Ridge Ave	Lombard Rd.

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS, be amended to add the following hereto:
