

## ORDINANCE NO. 5931

## AN ORDINANCE AMENDING ARTICLES VI AND XIX OF THE LOMBARD TRAFFIC CODE (ORDINANCE NO. 1186) IN RELATION TO CONSTRUCTION ZONE VIOLATION FINES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1**: That Article VI, Section 10-6-5G of the Lombard Traffic Code is amended to read in its entirety as follows:

"G. Any person found to be in violation of Subsection B above shall be fined not less than one hundred fifty and no/100 dollars (\$150.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees."

SECTION 2: That Article VI, Section 10-6-5 of the Lombard Traffic Code is amended by adding a new Subsection H thereto, which shall read in its entirety as follows:

"H. Any person found to be in violation of Subsection A above shall be fined not less than two hundred fifty and no/100 dollars (\$250.00) nor more than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees, for a first violation. Any person found to be in violation of Subsection A above a second or further time shall be fined not less than seven hundred fifty and no/100 dollars (\$750.00), exclusive of Court costs and fees."

**SECTION 3:** That Article XIX, Section 10-19-2 of the Lombard Traffic Code is hereby amended by adding the following language to the beginning thereof:

"Except as provided in Section 10-6-5 of this Traffic Code,"

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
