

ORDINANCE NO. 4770

AN ORDINANCE AMENDING TITLE 9, CHAPTER 92 OF THE LOMBARD VILLAGE CODE IN REGARD TO SERVICE FEES AND RATES RELATIVE TO THE PICK-UP OF REFUSE, YARD WASTE AND RECYCLABLES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, Du Page County, Illinois, as follows:

<u>SECTION 1:</u> That Title 9, Chapter 92, Section 92.17 of the Lombard Village Code is amended, effective April 1, 2000, to read in its entirety as follows:

"§ 92.17 SERVICE FEES AND RATES.

No authorized Waste Disposal Firm shall charge any fees in excess of those established herein. Service fees and rates shall be controlled by the following:

- (A) For Residential (single-family, duplex, triplex and quadruplex) units, the user fees for one (1) pick up per week shall be as follows:
- (1) Pick up of one (1) sixty-four (64) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm) at the curb...\$10.56 per month. (\$10.21 Waste Disposal Firm charge plus \$0.35 Village Service Fee).
- (2) Pick up of one (1) ninety (90) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm) at the curb...\$12.75 per month. (\$12.40 Waste Disposal Firm charge plus \$0.35 Village Service Fee).
- (3) Pick up of one (1) thirty-two (32) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm), relative to an authorized senior citizen account, at the curb...\$8.45 per month. (\$8.10 Waste Disposal Firm charge plus \$0.35 Village Service Fee).
- (4) Pick up of each non-Cart Waste Container in addition to the Cart Waste Container...\$1.05 per sticker, which shall be affixed to said non-Cart Waste Container.

(5) Pick up of Bulk Materials (as defined in the Village's Contract with the authorized Waste Disposal Firm):

\$20.00 per pick up.

(6) Pick up of White Goods (as defined in the Village's Contract with the authorized Waste Disposal Firm):

\$25.00 per pick up.

- (7) Pick-up of Large Items (as defined in the Village's Contract with the authorized Waste Disposal Firm)...\$1.05 per sticker which shall be affixed to each Large Item.
- (8) Pick-up of "Landscaping Waste" as defined by 415 ILCS 5/3.20...\$1.45 per sticker as defined by subsection (E) below. (\$1.35 Waste Disposal Firm charge plus \$0.10 Village Service Fee).
 - (9) Pick up of waste tires...\$5.00 per tire.
 - (10) Special collections...\$10.00 per cubic yard.
- (11) Backdoor service (as defined by the Village's Contract with the authorized Waste Disposal Firm)...\$20.00 per month, with said fee being in lieu of the fees set forth in subsections (1),(2) and (3) above.
- (B) For Commercial (non-residential and residential in excess of four units) units, the user fees shall be as follows:
- (1) Waste Containers located not more than twenty (20) feet from the roadway...\$0.054 per gallon per pick-up, but not less than \$17.41 per month.
- (2) Waste Disposal Firm supplied container service (one to six cubic yard containers): \$9.57 per cubic yard of container, per pick up, plus a \$17.17 per month fee for amortization of the container. In addition, said fee shall include a ninety-five (95) gallon cart container for Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm).
 - (3) Compactor container service: \$13.58 per cubic yard of container per pick-up.
- (4) Removal and disposal of Bulk Material (as defined in the Village's Contract with the authorized Waste Disposal Firm): \$10.94 per cubic yard, per pick up.
 - (5) Pick up of White Goods (as defined in the Village's Contract with the authorized Waste

Disposal Firm): Same fee as in subsection (A)(6) above.

- (6) Pick-up of "Landscaping Waste", as defined by 415 ILCS 5/3.20: Same fee as in Subsection (A)(8) above.
- (7) In addition to the foregoing charges, each multi-family residental Commercial customer/account shall be charged a Village Service Fee of \$0.10 per unit per month, and each non-multi-family residential Commercial customer/account shall be charged a Village Service Fee of \$3.00 per month.
- (C) Village Service Fees, in the amounts as set forth in subsections (A) and (B) above, are hereby established relative to the collection of refuse, recyclable materials and landscaping waste. Said Village Service Fees shall be collected by the authorized Waste Disposal Firm, from the person, firm or corporation that said authorized Waste Disposal Firm is performing services for, and shall be turned over to the Village at least once every three (3) months upon collection thereof.
- (D) A schedule of charges shall be furnished by the authorized Waste Disposal Firm to each customer.
- (E) For purposes of subsections (A)(8) and (B)(6) above, a "Sticker" shall cover the pick up of Landscape Waste in:
 - A Kraft Paper Bag;
 - (2) A non-Cart Waste Container; or
 - (3) A Bundle

The Sticker shall be affixed to the Kraft Paper Bag, Waste Container or Bundle (as said terms are defined in the Village's Contract with the authorized Waste Disposal Firm). Notwithstanding the foregoing, Bundles of Brush, as said terms are defined by the Village's Contract with the authorized Waste Disposal Firm, shall be picked up at no charge to the Residential customers.

(F) In the event that a request is made for a new or additional recycling bin, relative to a Residential unit that was previously issued a recycling bin, a recycling bin fee equal to the actual cost for the purchase of a recycling bin, as certified to the Village in writing by the Village's authorized Waste Disposal Firm, shall be added to the first garbage collection bill for said Residential unit

following the delivery of a new or additional recycling bin. Notwithstanding the foregoing, recycling bins replaced because the original bin was lost or damaged by the authorized Waste Disposal Firm shall be replaced by the authorized Waste Disposal Firm at no charge.

(G) The rates listed in this Section 92.17 shall be in full force and effect as of April 1, 2000."

SECTION 2: That Title 9, Chapter 92, Section 92.19 (B) of the Lombard Village Code is hereby repealed.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
