Subject: Request for "No Parking" on Hammerschmidt Ave.

Mr. Jerry Schaefer, 1012 Hammerschmidt Ave., requested that both sides of Hammerschmidt Ave. from Wilson Ave. to Central Ave. be posted "No Parking, School Days, 9 am- 3 pm" (see attached petition). Students from Glenbard East are parking their vehicles on both sides of the street and leaving trash for the neighbors to pick-up.

Hammerschmidt Ave. is a major truck route for all Public Works vehicles. Our snow plowing trucks are now larger and longer, which makes maneuvering around parked vehicles more difficult and hazardous.

I have reviewed this matter with Keith Surges, Operations Superintendent, and we both concur with the request to post both sides of Hammerschmidt Ave. from Wilson Ave. to Central Ave. "No Parking, School Days, 9 am- 3 pm".


