Title 11, Chapter 112, of the Lombard Village Code

Art Life Gallery & Studio - 425 S. Main St.

The Village has received a request for a liquor license from Art Life Gallery & Studio, Inc. d/b/a Art Life Gallery & Studio located at 425 S. Main Street. Art Life Gallery & Studio will function as an art gallery offering original artwork from local talent and handmade gifts as well as a studio/classroom area to provide learning opportunities for adults and children. Their intent is to serve beer, wine and champagne to a patron that is attending an artist reception, artistic experience event or other private event. The licensee/patrons may bring food onto the premises from local restaurants but none shall be prepared on the licensed premises.

Currently, Village Code does not have a liquor license classification that would fit Art Life Gallery & Studio's liquor license request. Staff met with the applicant and thereafter requested that Village Counsel prepare an ordinance creating a new "VV" liquor classification as well as to amend other sections of Code within Chapter 112 which will be affected by the creation of the "VV" liquor classification.

The petitioner has requested that first reading be waived in anticipation of their projected opening date.

ORDINANCE NO. __

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND A NEW CLASS "VV" LIQUOR LICENSE CATEGORY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "VV" liquor license category, to read in its entirety as follows:

"Class "VV" — Beer, wine and champagne only, served as an adjunct to an art gallery and studio. No package sales shall be allowed. Beer, wine and champagne may only be served to a patron of the licensed premises, that is attending an artist reception, artistic experience event or other private event at the licensed premises. There shall be no consumption of alcoholic beverages, on the licensed premises, other than those supplied by the licensee. Patrons may bring food to the licensed premises, and the licensee may have food brought to the licensed premises from local restaurants, for consumption on the licensed premises, but no food shall be prepared on the licensed premises."

SECTION 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language relative to a new Class "VV" liquor license thereto, which shall read in its entirety as follows:

"Class "VV" - 1"

This increase in the number of Class "VV" liquor licenses reflects the issuance of a new Class "VV" liquor license to Art Life Gallery & Studio, Inc. d/b/a Art Life Gallery & Studio, located at 425 South Main Street, Lombard, Illinois.

SECTION 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "VV" liquor license category, to read in its entirety as follows:

"Class "VV" - \$500.00"

SECTION 4: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "all Class A/B-I, A/B-II, A/B-IV, C, D, E, I, K, L-I, L-II, M, O, R, S, T-I, T-III, U, V, X and Z liquor license holders," to read, "all Class A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E, I, K, L-I, L-II, M, O, R, S, T-I, T-III, T-III, U, V, VV, X and Z liquor license holders."
