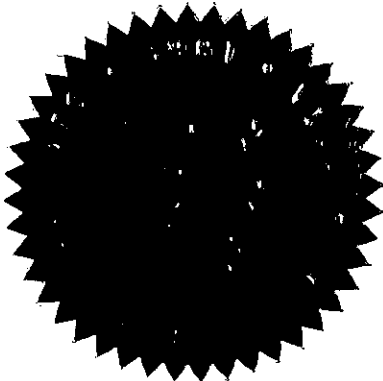

ORDINANCE 4377

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter referred to as the "Lombard Traffic Code"); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule V of the Lombard Traffic Code, entitled PREFERENTIAL STREETS be amended to add the following thereto:

Wilson Ave. will yield to Addison St.
 North Cambria Lane will yield to Addison St.
 South Cambria Lane will yield to Addison St.

Section 2: That Schedule XXII (e) of the Lombard Traffic Code, entitled NO STOPPING, STANDING OR PARKING 8a.m. - 3p.m. on school days be amended to add the following thereto:

Name of Street	From	To
School Street	south curb line of Division St.	north curb line of Washington Blvd.
Ahrens Ave. east side	790 feet north of the north curb line of Washington Blvd.	south curb line of Division St.
Ahrens Ave. west side	north curb line of Washington Blvd.	south curb line of Division St.

Section 3: That Schedule XXII (b) of the Lombard Traffic Code, entitled NO STOPPING, STANDING OR PARKING 8 a.m. - 4p.m. on school days be amended to delete the following therefrom:

School St. east side south curb line of Division St. Washington Blvd.

Ahrens Ave. east side north curb line of Washington Blvd.

Ahrens Ave. west side north curb line of Washington Blvd. south curb line of Division St.

Section 4: That Schedule VIII (g) of the Lombard Traffic Code, entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS 8a.m. - 3p.m. on school days be amended to add the following thereto:

To

School St. west side 310 feet south of the south curb line of Division St. a point 360 feet south

Section 5: That Schedule VIII (o) of the Lombard Traffic Code, entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS 8a.m. - 4p.m. on school days be amended to delete the following therefrom:

To

School St. west side 310 feet south of the south curb line of Division St. a point 360 feet south

Section 6: That Schedule VI of the Lombard Traffic Code, entitled ONE-WAY STREETS be amended to add the following thereto:

Name of Street

Direction of Traffic Movement

North

Ahrens Ave. from Washington Blvd. to Division St. between 8a.m. and 3p.m. on school days

South

School St. from Division St. to Washington Blvd. Between 8a.m. and 3p.m. on school days

Section 7: That Schedule VI of the Lombard Traffic Code, entitled ONE-WAY STREETS be amended to delete the following therefrom:

Name of Street

Direction of Traffic Movement

North

Ahrens Ave. from Washington Blvd. to Division St. between 8a.m. and 4p.m. on school days

South

School St. from Division St. to Washington Blvd. Between 8a.m. and 4p.m. on school days

Section 8: That this Ordinance shall be in full force and effect from and after its passage, adoption, publication in pamphlet form and the posting of appropriate signs as provided by law.






