Attached is an ordinance, effective January 1, 2023, amending Title XI, Chapter 112, Section 112.13(A) of the Village Code decreasing the number of entries in the Class "FFF" liquor license classification as a result of Aftherthought Brewing LLC d/b/a Afterthought Brewing located at 844 N. Ridge Avenue voluntarily not renewing their liquor license for the January 1 through June 30, 2023 licensing term.

**SUBJECT: Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code
Alcoholic Beverages
Voluntary Non-Renewal of Liquor License**

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff is currently in the renewal process for the January 1 through June 30, 2023 licensing term. The owner of Afterthought Brewing LLC d/b/a Afterthought Brewing, located at 844 N. Ridge Avenue, notified the Village staff that the licensee will voluntarily not renew their liquor license for the upcoming licensing term.

Attached is an ordinance decreasing the number of entries in the “FFF” liquor license classification by one, effective January 1, 2023, to account for their voluntary non-renewal.

Staff is requesting a waiver of first reading in order to bring the number of entries in each liquor classification current.

ORDINANCE

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE
NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS
“FFF” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective January 1, 2023, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class “FFF” liquor licenses, contained therein, to read as follows:

Class “FFF” – 0

SECTION 2: That, effective January 1, 2023, the decrease in the number of Class “FFF” liquor licenses set forth in Section 1 above is a result of Afterthought Brewing, LLC d/b/a Afterthought Brewing, 844 N. Ridge Avenue, voluntarily not renewing their liquor license for the January 1 through June 30, 2023 liquor licensing term.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
