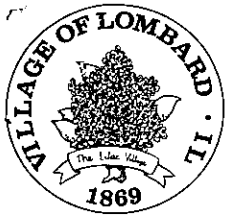

**Subject:** Recommendations from the Transportation and Safety Committee

At the June 14, 2004, Transportation and Safety Committee meeting, the committee recommended the following items:

- Reduce the speed limit on Fairfield Avenue between Roosevelt Road and Wilson Avenue from 30 MPH to 25 MPH
- Reduce the speed limit on Maple Street between Vance Street and Addison Street from 30 MPH to 25 MPH
- Install multi-way stop controls at Edson Avenue and Hickory Street
- Post "No Parking, Stopping, Standing, 3:00pm – 3:30pm, School Days" on the north side of Green Valley Drive at its intersection with Green Valley Drive West to a point 550 feet east of the intersection
- Install "Yield" signs on northbound and southbound Lodge Avenue at Emerson Avenue
- Install "Yield" signs on northbound and southbound Lewis Avenue at Emerson Avenue

The following sections of the traffic code require an ordinance:

**Add:** Schedule I – Section 10-16-1(c) – Altered Maximum Speed Limits

Fairfield Avenue from Roosevelt Road to Wilson Avenue, maximum speed 25 MPH

Maple Street from Vance Street to Addison Street, maximum speed 25 MPH

**Add:** Schedule III – Section 10-9-3 – Stop Intersection

Edson Avenue and Hickory Street

**Delete:** Schedule IV – Section 10-9-4 – Stop Streets

Hickory Street shall stop at Edson Avenue

**Add:** New Schedule XX(f) – No Stopping, Standing or Parking 3:00pm – 3:30pm, School Days

North side of Green Valley Drive from the east curb line of Green Valley Drive West to a point 550 feet east.

**Add:** Schedule V – Section 10-9-5 – Preferential Streets

Lodge Avenue will yield to Emerson Avenue

Lewis Avenue will yield to Emerson Avenue

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>	<u>Max Speed</u>
Fairfield Avenue	Roosevelt Rd.	Wilson Ave.	25 MPH
Maple Street	Vance Street	Addison Street	25 MPH

Section 2: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Hickory Street	“	Edson Avenue

Section 3: That Schedule III of the Lombard Traffic Code (Ordinance 1186) entitled STOP INTERSECTIONS be amended to add the following thereto:

Edson Avenue and Hickory Street

Section 4: That Schedule XX (f) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING during the hours of 3:00 p.m. to 3:30 p.m. on school days be amended to read in its entirety as follows:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Green Valley Drive North side	east curb line of Green Valley Drive West	a point 550 feet east

Section 5: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to add the following thereto:

Lodge Avenue will yield to Emerson Avenue  
Lewis Avenue will yield to Emerson Avenue

Section 6: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
