**SUBJECT:** Cruise Nights/Temporary Parking Restrictions

Cruise Nights will commence on June 15, 2024 through and including August 24, 2024, excluding July 6, 2024.

The following parking restrictions are adopted each year in support of Cruise Nights. These restrictions limit parking on certain Saturday nights along St. Charles Road between Main Street and N. Lincoln Avenue, between the hours of 6 p.m. and 10 p.m., and along Park Avenue between Orchard Terrace and Michael McGuire Drive from the hours of 3:00 p.m. to 10:00 p.m.

**A RESOLUTION TEMPORARILY LIMITING PARKING ALONG ST. CHARLES ROAD  
BETWEEN MAIN STREET AND N. LINCOLN AVENUE AND  
ALONG PARK AVENUE BETWEEN ORCHARD TERRACE  
AND MICHAEL MCGUIRE DRIVE**

**WHEREAS**, the Village of Lombard wishes to host and otherwise operate “Cruise Nights & Summer Concerts,” on Saturday nights in the summer commencing June 15, 2024, through and including August 24, 2024 (excluding July 6);

**WHEREAS**, it is necessary to limit parking along St. Charles Road between Main Street and N. Lincoln Avenue and along Park Avenue between Orchard Terrace and Michael McGuire Drive, during the various “Cruise Nights” as described above, to allow for the event to take place;

**NOW, THEREFORE, Be It Resolved** by the President and Board of Trustees of the Village of Lombard, Du Page County, Illinois, as follows:

**SECTION 1:** That the portion of St. Charles Road between Main Street and N. Lincoln Avenue, excluding those parking spaces restricting vehicle parking to 15 minutes, and along Park Avenue, between Orchard Terrace and Michael McGuire Drive, shall be closed to public parking on the following dates:

June: 15, 22, and 29      July: 13, 20, and 27      August: 3, 10, 17, 24

In the event that a “Cruise Night” does not occur on one or more of the aforementioned dates, the parking restriction, as set forth in this Section, shall not be applicable on said date(s).

**SECTION 2:** That the Village of Lombard, by and through its Cruise Nights volunteer staff members, shall determine at its sole discretion which vehicles participating in “Cruise Nights”, if any, shall be allowed to park on the portion of St. Charles Road between Main Street and N. Lincoln Avenue during the time period of 6:00 p.m. to 10:00 p.m., and on the portion of Park Avenue between Orchard Terrace and Michael McGuire Drive which is closed to public parking during the time periods of 3:00 p.m. to 10:00 p.m.

**SECTION 3:** That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.
