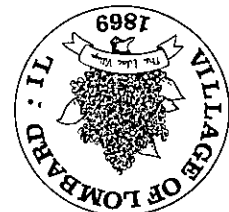

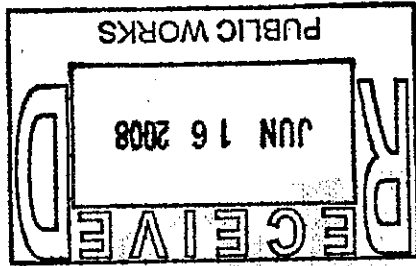
SUBJECT: Amendment to Title 11, Chapter 121, Section 121.03 of the Lombard Village Code in Regard to the Number of Public Passenger Licenses

All-Star Cab Dispatch, Inc. has applied for a license to operate a Taxi Company in the Village of Lombard. This request was brought to the Transportation and Safety Committee on August 4, 2008. At that time approval of a business license allowing All-Star Taxicab to operate in the Village of Lombard was recommended.

The business license application along with a copy of insurance information has been provided. Reference checks were also made with the Villages of Oakbrook, Carol Stream and Addison which resulted favorable.

ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 121, SECTION 121.03 OF THE LOMBARD VILLAGE CODE IN REGARD TO PUBLIC PASSENGER LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 121, Section 121.03 (A) (2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be six (6) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of granting a business license to All-Star Cab Dispatch, Inc. located at 1124 Algonquin Rd., Lake in the Hills, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
