TERMINATION AND RELEASE AGREEMENT

THIS TERMINATION AND RELEASE AGREEMENT (this "Agreement") is made and entered into as of , 2004 by and between THE VILLAGE OF LOMBARD ("Village"), and ELMHURST MEMORIAL HEALTHCARE ("EMHC").

WITNESSTH:

- A. The Village and EMHC's predecessor in interest entered into that certain Redevelopment Agreement dated as of August 4, 1997 as amended by First Amendment to Redevelopment Agreement dated September 2, 1997 (as amended, "Redevelopment Agreement") affecting that certain real property commonly known as 29-37 East St. Charles Road, Lombard, Illinois and legally described on Exhibit A attached hereto and incorporated herein by this reference ("Property") and such Redevelopment Agreement was approved by the Village pursuant to Resolution No. 16-98 dated July 17, 1997 and recorded as Document No. 97-137213 ("Resolution").

- 2. Release. EMHC and the Village hereby forever release the Property and each other from any and all liabilities, costs, expenses and obligations arising under or pursuant to the Redevelopment Agreement.
- 3. Authorization. The undersigned individuals executing this Agreement on behalf of a party hereto does hereby represent and warrant that (s)he is fully empowered and authorized to execute this Agreement on behalf of such party.
