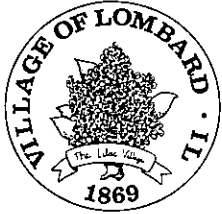

Subject: Award Bid #FS0809, one new tandem axle dump truck with plow

The FY 2008 budget includes replacement of ST340, a single axle dump truck with plow. The bid results are as follows:

Vendor	Bid Price	Less Trade-In	Net Total Bid
Northwest Ford Franklin Park, IL	175,402	15,500	159,902
Chicago International Trucks Melrose Park, IL	178,999	20,000	158,999
Rendel's GMC Joliet, IL	182,852	14,500	168,352

Public Works received three sealed bids. Northwest Ford was the only bidder that met our specifications. The bid price for the new tandem axle dump truck with plow is \$175,402 less a trade-in allowance of \$15,500 equals a net total bid of \$159,902. The budgeted amount for this vehicle is \$176,000.

I recommend the award of a contract to Northwest Ford of Franklin Park, IL. in the amount of \$159,902. I also recommend declaring village unit number 343, a 1997 International single axle dump truck with plow, as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the April 5, 2007 meeting.

**ORDINANCE AUTHORIZING THE SALE AND/OR DISPOSAL
