**Stanley Cup Finals** 

At The May 7, 2015 Village Board meeting, one outdoor viewing event for a Chicago Blackhawks game was approved to be held on or before June 7, 2015. However, the current schedule has games three through seven scheduled after June 7, 2015.

Attached is an ordinance amending Ordinance No. 7074 to allow for an extension for the event to be held on or by June 17, 2015.

Should the aforementioned Ordinance be approved, staff will work with the relevant parties (i.e., Punky's, Shannon's and Lombard Town Centre), to finalize the plans for any such viewing events. Issues to be finalized include specific dates and times, event conflicts, Village staff labor/staffing, equipment availability, and outdoor space availability. The event would be similar in design and operations as the other outdoor viewing events in 2013 and 2014. The date and time has not been set.

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That the references to "June 7, 2015," as contained in Sections 1 and 2 of Ordinance No. 7074, adopted May 7, 2015, and as contained in new subsection (7) to Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code, as added to the Lombard Village Code by said Ordinance No. 7074, adopted May 7, 2015, are hereby all amended to read "June 17, 2015."

**SECTION 2:** That all other provisions of Ordinance No. 7074, adopted May 7, 2015, and Title 11, Chapter 112, Section 112.18(B)(7) of the Lombard Village Code, not amended hereby, shall remain in full force and effect.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
