Removal of the No Parking 7am-4pm M-F sign: Broadview Ave. from North Ave to dead end.  
Adding No Commercial Truck Parking from North Ave to dead end on Broadview.

I am requesting for the removal of the No Parking 7-am-4pm M-F in the area of 711 N. Broadview (North Ave. near the dead end). I am requesting that we place a No Commercial Trucks Parking at all times in the area.

With the new addition of the Thornton's Gas Station/ Truck Stop (511 W. North Ave.), numerous trucks are parking on Broadview for long periods of time causing many problems for the resident at 711 N. Broadview. Mail deliveries and garbage pick-ups have stopped at times because trucks are blocking the driveway. Truck drivers should not be parking/abandoning their trucks on Broadview and should be parking in the parking lot at Thornton's which it was designed.

We all know that trucks cause more damage to roads than a normal car. They are damaging the roadway when turning around and knocking down signs in the area while attempting to park.

I spoke to Joana who lives at 711 N. Broadview and she strongly agrees that there should be no commercial parking on Broadview. I also spoke to Becky at Lombard Assembly of God located at 447. W. North Ave. She agrees that there should be no commercial parking at all times on Broadview.

The Police Department's recommendation to remove the sign and add the new signage was made at the March 3, 2021 PSTC meeting. The PSTC approved the request and the Police Department's recommendation.

Ordinance No. 1186

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: SCHEDULE VIII - PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS of the Lombard Traffic Code (e) In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall park a vehicle in any of the following places during the hours of 7:00 A.M. to 4.00 P.M. on Mondays through Fridays: is amended to reflect the removal of the Broadview Avenue from North Ave to dead end.

ADDING TO: That Schedule VIII (PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS) of the Lombard Traffic Code is amended to reflect the addition of the following:

“(w) In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall, at any time, park a commercial vehicle in any of the following places: Broadview from North Ave. to dead end. “

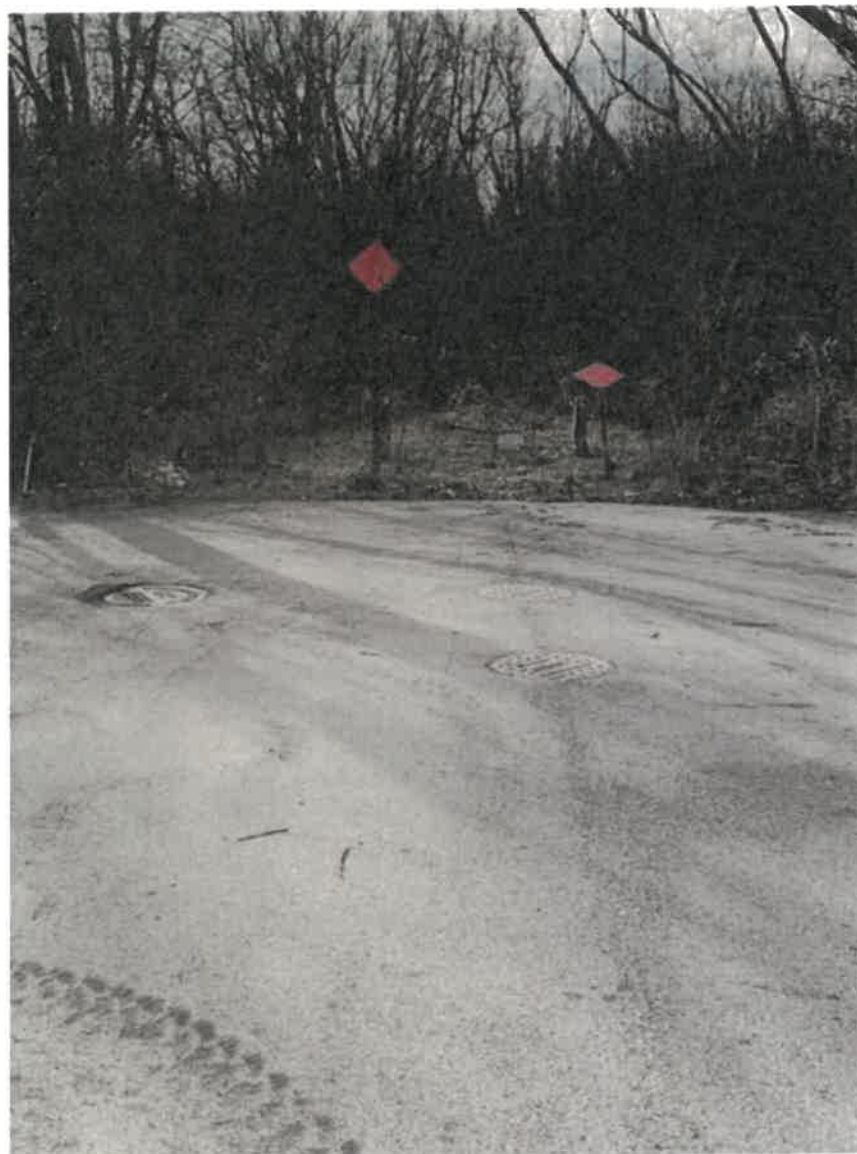

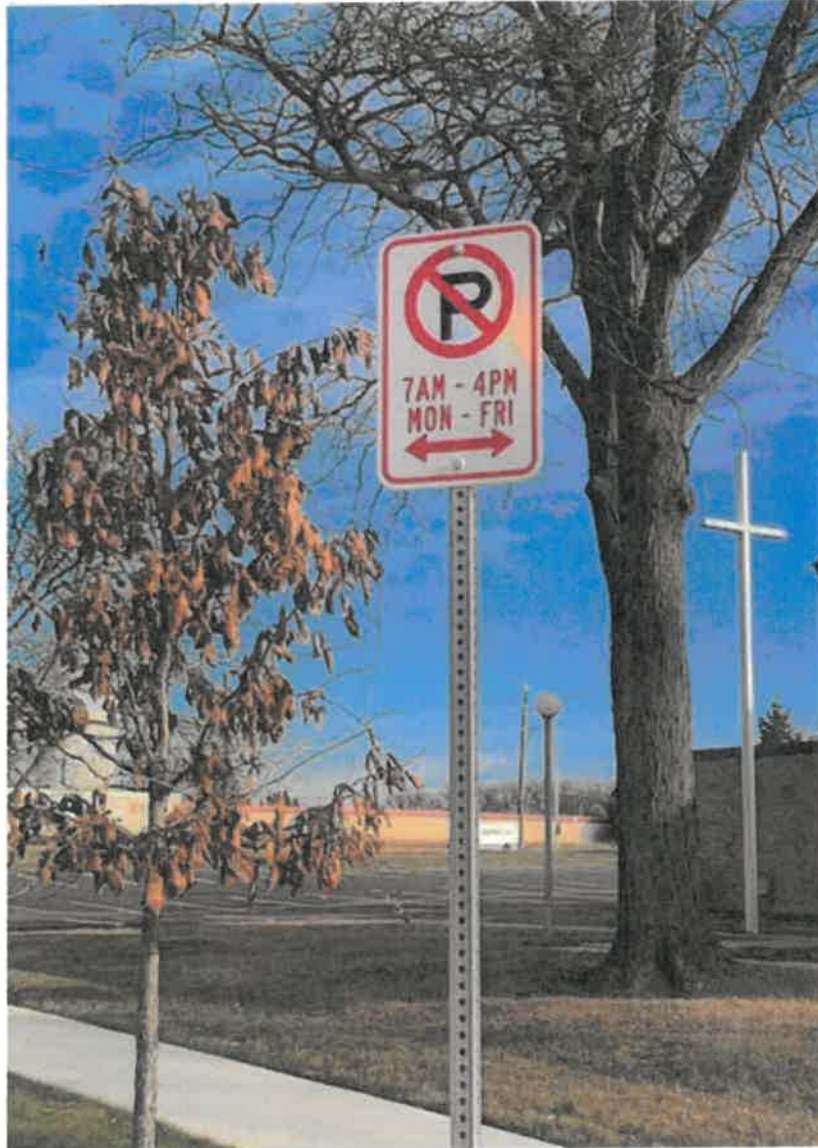
