The Engineering Division sent a Request for Proposal for design engineering services for the Westmore-Meyers Road Resurfacing project, consisting of underground improvements and a LAPP improvement to firms on the FY05 Roadway Design Short List. Four of the six firms solicited submitted proposals. Burns & McDonnell of Downers Grove, Illinois was determined to be the most qualified firm for this project. Burns & McDonnell has completed the design engineering for the first phase of the Yorktown Watermain projects and is continuing with the engineering for subsequent phases. They have also successfully performed on other contracts with the Village.

The design engineering contract award is a not to exceed amount of \$203,405 for the design and preparation of two sets of construction documents for the Westmore-Meyers Road Resurfacing project. The first set of construction documents is for underground improvements and the second set is for the Local Agency Pavement Preservation (LAPP) improvements. This approach is the same as was done for the Main Street Improvements (Underground and LAPP). Funding for construction for the underground improvements will be with village funds, while the LAPP improvements include federal funds (STP funding through the DuPage Mayors and Managers Conference).

Please present this agreement and resolution to the President and Board of Trustees for their review and approval at their regular meeting on September 1, 2005. If approved, please have both signed copies returned to Engineering for further processing.
