SUBJECT: **Text Amendment to Title 11, Chapter 121, Section 121.03A.(2)**
Number of Taxicab Licenses

All business licenses, including taxicab licenses, expire on the 30th day of June and must be renewed if they desire to operate within the Village of Lombard.

As part of the renewal process, AM Regional Taxi, Inc. held a business license to operate a taxicab company in the Village of Lombard. Since January, 2013, AM Regional has not been providing taxicab service but has been operating as a cab leasing company which does not require a taxicab business license.

Metro Yellow Taxi Inc. has indicated they will no longer be operating within the Village of Lombard and would not be renewing their business license.

Title 11, Chapter 121, Section 121.03A.(2) currently allows 12 taxicab business licenses to be issued. With AM Regional Taxi and Metro Yellow Taxi not renewing their business licenses, Village Code is being amended to reflect this change and allow 10 taxicab business licenses.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be ~~ten (10) twelve (12)~~ Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of removing two business licenses; one to Metro Yellow LLC d/b/a Metro Yellow located at 5105 Pearl St., Schiller Park IL and the other to AM Regional Taxi Inc. d/b/a AM Regional Taxi located at 5403 Patton Dr., Lisle, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
