## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.12(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE CLASS "ZZ" LIQUOR LICENSE CLASSIFICATION

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding a new subsection 3 to the description of the Class "ZZ" liquor license, which shall read in its entirety as follows:

"3. Sales of beer and wine shall be made at a cash register dedicated solely to the sale of beer and wine, with no other merchandise being sold using said cash register."

In addition, the description of the Class "ZZ" liquor license is amended by deleting the word "and" at the end of subsection 1, and by changing the period (.) at the end of subsection 2 to read, "; and".

**SECTION 2**: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
