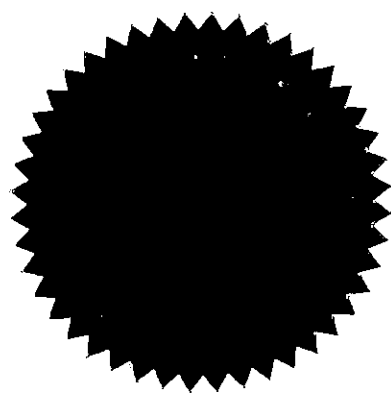

ORDINANCE 5140

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO LIQUOR LICENSE CLASSIFICATIONS (GIFT BASKET/SPECIAL OCCASION LIMITED PACKAGE SALES - FLORIST)

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code

is amended by revising the description for the Class "Q" liquor license to read in its entirety as

follows:

"Class "Q" - Package sales of wine and champagne only, as an adjunct to a full service florist shop, subject to the following conditions:

1. The wine and champagne shall be sold either in gift baskets or by the bottle with a specialty label (special event/occasion label);
2. Display of the wine and champagne on the licensed premises shall be limited to samples/samples only, with all sales of wine and champagne resulting solely from special orders of gift baskets and/or specialty labeled bottles; and
3. No more than twenty-five percent (25%) of the gross receipts of the business can result from the sale of the wine and champagne."

SECTION 2: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code

is amended by revising the entry relative to a Class "Q" liquor license to read as follows:

"Class "Q" - \$250.00"

SECTION 3: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code

is amended by revising the entry relative to the Class "Q" liquor license to read as follows:

"Class "Q" - 1"

This increase in Class "Q" liquor licenses reflects the issuance of a Class "Q" liquor license to

Shamrock Gardens Florist, Inc. located at 901 East St. Charles Road, Lombard, Illinois.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage,

approval and publication in pamphlet form as provided by law.






