

## ORDINANCE 4826

# AN ORDINANCE AMENDING TITLE 15, CHAPTER 155, OF THE LOMBARD VILLAGE CODE IN REGARDS TO DAY CARE CENTERS, EDUCATIONAL SERVICES, EDUCATIONAL INSTITUTIONS, AND CULTURAL FACILITIES

(PC 00-22)

WHEREAS, the Village of Lombard maintains a Zoning Ordinance which is found in Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, the Board of Trustees deem it reasonable to periodically review said Zoning Ordinance and make necessary changes; and,

WHEREAS, a public hearing to consider a text amendment to the Zoning Ordinance has been conducted by the Village of Lombard Plan Commission on May 15, 2000 pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the text amendment described herein; and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Title 15, Chapter 155, Section 404.B, Permitted Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

#### (B) Permitted Uses

The following uses shall be permitted in the CR District:

- (1) Botanical gardens and arboretums
- (2) Golf courses, tennis courts, and similar open recreational activities.

- (3) Parks and playgrounds
- (4) Schools, Public, Full-Time: Elementary, Middle, and High
- (5) Zoological gardens
- (6) Accessory uses and buildings, incidental to and on the same zoning lot as the permitted use, which are constructed and operated in conformance with Section 155.210 of this Ordinance.

SECTION 2: That Title 15, Chapter 155, Section 404.C, Conditional Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

## (C) Conditional Uses

Subject to the provisions of Section 155.103 (F) of this Ordinance, the following conditional uses may be allowed:

- (1) Colleges and universities
- (2) Cultural facilities / institutions
- (3) Day care centers
- (4) Municipal facilities
- (5) Nurseries, for the growing and sale of trees and shrubbery
- (6) Planned developments in conformance with Section 9 of this Ordinance
- (7) Schools, Private, Full-Time: Elementary, Middle, and High
- (8) Recreational and social facilities
- (9) Accessory uses and buildings, incidental to and on the same zoning lot as the conditional use, which are constructed and operated in conformance with Section 155.210 of this Ordinance

SECTION 3: That Title 15, Chapter 155, Section 405.C, Conditional Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

(C) Conditional Uses

- (1) Cemeteries
- (2) Colleges or universities
- (3) Cultural facilities / institutions
- (4) Group Care Facilities, in conformance with Section 155.219 of this Ordinance
- (5) Planned developments in conformance with Section 155.500 of this Ordinance
- (6) Public and private utility and municipal service uses
- (7) Public recreational and social facilities, as follows:
  - (a) Golf courses, but not golf driving ranges, pitch and putt, or miniature golf courses
  - (b) Recreational clubs, noncommercial
  - (c) Parks and playgrounds
  - (d) Recreational buildings and community centers, noncommercial
  - (e) Swimming pools, noncommercial
  - (f) Tennis clubs and courts, noncommercial
- (8) Religious institutions, as follows:
  - (a) Churches, chapels, temples, and synagogues
  - (b) Convents, seminaries, mon-asteries, and nunneries
  - (c) Rectories and parish houses
  - (d) Religious retreats

- (9) Schools, Private, Full-Time: Elementary, Middle, and High
- (10) Schools, Public, Full-Time: Elemantary, Middle, and High
- (11) Accessory uses and buildings, incidental to and on the same zoning lot as the conditional use, which are constructed and operated in conformance with Section 155.210 of this Ordinance

SECTION 4: That Title 15, Chapter 155, Section 406.C, Conditional Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

# (C) Conditional Uses

- (1) Cemeteries
- (2) Colleges or universities
- (3) Cultural facilities / institutions
- (4) Group Care Facilities, in conformance with Section 155.219 of this Ordinance
- (5) Hospitals
- (6) Planned developments in conformance with Section 155.500 of this Ordinance
- (7) Public recreational and social facilities, as defined in the R1 District
- (8) Public utility and service uses and civic buildings
- (9) Religious institutions, as defined in the R1 District
- (10) Schools, Private, Full-time: Elementary, Middle, and High

Subject to the provisions of Section 155.102 (F) of this Ordinance, the following conditional uses may be allowed:

- (1) Colleges or universites
- (2) Cultural facilities / institutions
- (3) Group Care Facilities, in conformance with Section 155.219 of this Ordinance
- (4) Hospitals
- (5) Planned Developments
- (6) Public recreational and social facilities, as defined in the R1 District
- (7) Public utility and service uses and civic buildings.
- (8) Religious institutions, as defined in the R1 District
- (9) Schools, Private, Full-time: Elementary, Middle, and High
- (10) Schools, Public, Full-time: Elementary, Middle, and High
- (11) Accessory uses and buildings, incidential to and on the same zoning lot as the conditional use, which are constructed and operated in conformance with Section 155.210 of this Ordinance.

  - (a) Hospitals
  - (b) Medical and dental clinics
- (8) Hotels and Motels
- (9) Off-site parking, in conformance with Section 155.602 (A) (3) (b) of this Ordinance

- (10) Parking lots and garages, other than accessory, for the storage of private passenger automobiles only
- (11) Planned developments in conformance with Section 155.500 of this Ordinance
- (12) Public utility and public service uses as follows:
  - (a) Fire stations
  - (b) Police stations
  - (c) Post offices
  - (d) Telephone exchanges, telephone transmission equipment buildings, and microwave relay towers
- (13) Recreational and social facilities, including:
  - (a) Parks and playgrounds
  - (b) Recreational buildings and community centers (non-commercial)
- (14) Restaurants including entertainment and/or dancing
- (15) Schools, Private, Full-time: Elementary, Middle, and High
- (16) Schools, Public, Full-time: Elementary, Middle, and High
- (17) Accessory uses and buildings, incidental to and on the same zoning lot as the principal use, which are constructed and operated in conformance with Section 155.210 of this Ordinance.

SECTION 11: That Title 15, Chapter 155, Section 412.BPermitted Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

#### B. Permitted Uses

The following uses shall be permitted in the B1 District:

- (1) Antique shops
- (2) Art and school supply stores

- (3) Art shops or galleries, but not including auction rooms
- (4) Bakeries, retail only
- (5) Barber shops
- (6) Beauty shops
- (7) Book and stationery stores
- (8) Candy and ice cream stores
- (9) China and glassware stores
- (10) Clothiers pressing establishments
- (11) Coin and philatelic stores
- (12) Custom dressmaker
- (13) Drug stores
- (14) Dry cleaning and laundry receiving stations only, processing to be done elsewhere
- (15) Dry goods stores
- (16) Dwelling units, located above the first floor, provided: at least fifty percent (50%) of the square footage of the Building Footprint on the Ground Floor is devoted to uses permitted (Permitted Uses and/or approved Conditional Uses) in this district, other than uses referenced in Sections 155.412(B)(38), 155.412(C)(2), and 155.412(C)(9).
- (17) Financial Institutions
- (18) Flower shops
- (19) Food stores, grocery stores, meat markets and delicatessens including carryout and delivery
- (20) Gift shops

- (21) Hardware stores
- (22) Hobby shops, for retail sales of items to be assembled or used away from the premises
- (23) Jewelry stores, including watch repair
- (24) Launderettes, automatic, self-service only or hand laundries
- (25) Learning Centers, with no outdoor component
- (26) Offices--business or professional
- (27) Outpatient Medical Care Facility
- (28) Pet Grooming Services (not including animal hospitals or overnight visits)
- (29) Post office
- (30) Restaurants, not including entertainment and dancing
- (31) Shoe, clothing, and hat repair stores
- (32) Silk screening services
- (33) Sign Printers
- (34) Tanning Salon
- (35) Wearing apparel shops
- (36) Variety shops
- (37) Video tapes, sale and rental of, electronic game cartridges and similar items
- (38) Accessory uses and buildings, incidental to and on the same zoning lot as the permitted use, which are constructed and operated in conformance with Section 155.210 of this Ordinance

SECTION 12: That Title 15, Chapter 155, Section 412.C Conditional Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

- (12) Medical and dental laboratories
- (13) Meeting hall
- (14) Motor vehicle sales

- (30) Accessory uses and buildings, incidental to and on the same zoning lot as the conditional use, which are constructed and operated in conformance with Section 155.210 of this Ordinance

SECTION 19: That Title 15, Chapter 155, Section 416.B Permitted Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

#### B. Permitted Uses

Any use permitted in the B3 District shall be permitted in the B5 District, and in addition, the following uses shall be permitted in the B5 District:

- (1) Dwelling units, located above the first floor, provided:
  - (a) the Building in which the Dwelling Units are located extends across the entire Frontage of the zoning Lot on which the Building is located, except for areas necessary for driveway access to parking spaces;
  - (b) at least fifty percent (50%) of the square footage of the Building Footprint on the Ground Floor is devoted to uses permitted (Permitted Uses and/or approved Conditional Uses) in the B5 Central Business District, other than uses referenced in Sections 155.416(B)(9), 155.416(C)(6), 155.416(C)(9) and 155.416(C)(16); and
  - (c) no Parking Spaces exist in either the Front Yard or Corner Side Yard.
- (2) Coffee Shop
- (3) Financial institutions
- (4) Hotels and motels
- (5) Offices, including business, professional, non-profit and governmental offices
- (6) Outdoor Cafe, in conformance with Section 155.802 and Chapter 119 of this Code.
  - (7) Theaters, indoor only

SECTION 20: That Title 15, Chapter 155, Section 416.C Conditional Uses, of the Code of Lombard, Illinois is hereby amended to read in its entirety as follows:

# (C) Conditional Uses

- (1) Amusement establishments, indoor only, including; bowling alleys, pool halls, swimming pools, skating rinks.
- (2) Animal hospitals and kennels
- (3) Automobile service

- (4) Catering businesses on the first floor as a primary use but only if, as an accessory use, either a restaurant, excluding entertainment and dancing, or a related, permitted retail use, designed to generate walk-in trade, is located in the storefront.
- (5) Convention and exhibition halls
- (6) Day Care Centers
- (7) Farmer's Market
- (8) Funeral homes
- (9) Gasoline sales
- (10) Learning Centers, with outdoor component
- (11) Off-site parking, in conformance with Section 155.602 (A) (3) (b) of this Ordinance
- (12) Outside display and sales of products the sale of which is a permitted or conditional use in this district
- (13) Outside service areas for other permitted or conditional uses in this district
- (14) Parking lots or structures, commercial
- (15) Planned developments in conformance with Section 155.500 of this Ordinance
- (16) Public utilities and services
- (17) Religious institutions, as defined in the R1 District
- (18) Transportation depots
- (19) Accessory uses and buildings, incidental to and on the same zoning lot as the conditional use, which are constructed and operated in conformance with Section 155.210 of this Ordinance

SECTION 21: That Title 15, Chapter 155, Section 802 Rules and Definitions, of the Code of Lombard, Illinois is hereby amended to include the following:

Cultural facilities / institutions a library, museum, or similar public or quasi-public use displaying, preserving, and exhibiting, or allowing for the use, but not the sale of, objects of community or cultural interest in one or more of the arts or sciences.

Learning Centers which include, but are not limited to, instruction in art, dance, photography, sculpture, language, student tutoring, testing centers, etc., but which do not include adult uses, trade schools, or public or private full-time schools.

Schools, Private, Full-Time: Elementary, Middle, High any building, group of buildings, or portion of a building used for full-time education which meets state requirements for elementary, secondary, or higher education and which does not secure the major part of its funding from any governmental agency.

Schools, Public, Full-Time: Elementary, Middle, and High any full-time school which is licensed by the state and which meets the state requirements of a school.
