ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 110,
SECTION 110.21 OF THE LOMBARD VILLAGE CODE IN
REGARD TO COIN-OPERATED AMUSEMENT DEVICES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 110, Section 110.21 (C) of the Lombard Village Code is amended by revising the entry relative to Class B contained therein to read as follows:

Class B
Seven (7) to ten (10) coin-operated amusement devices
No more than three (3) licenses.

Section 2: That the change in the number of Class B licenses set forth in Section 1 above, is a result of granting a license to JNJS Pizza Inc. doing business as Roundhead's Pizza located at 275 W. Roosevelt Road, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
