SUBJECT: **Liquor License Classification Changes**

Please be advised liquor license holders with a Class A/B license are required to report their annual gross dollars of alcoholic liquor sales yearly. Two (2) of our liquor license holders require a change in their classifications as follows:

DMK Burger Bar 2, LLC d/b/a DMK Burger Bar, located at 2370 Fountain Square Drive, reported a decrease in their 2011 sales which changes their classification from a Class A/B III to a Class A/B II; and

JNJS Pizza Inc. d/b/a Roundheads Pizza located at 275 W. Roosevelt Road, reported an increase in their 2011 sales which changes their classification from a Class A/B II to a Class A/B III.

ORDINANCE _____
AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B II liquor licenses, contained therein, to read as follows:

“Class A/B II – 11”

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B III liquor licenses, contained therein, to read as follows:

“Class A/B III – 14”

SECTION 3: That the changes in the number of Class A/B II and A/B III liquor licenses set forth in Sections 1 and 2 above are as a result of DMK Burger Bar 2, LLC d/b/a DMK Burger Bar, located at 2370 Fountain Square Drive, reporting a decrease in their gross dollars of liquor sales in calendar year 2011, resulting in a change from a Class A/B III liquor licensee to a Class A/B II liquor licensee; JNJS Pizza Inc. d/b/a Roundheads Pizza, located at 275 W. Roosevelt Road, reporting an increase in their gross dollars of liquor sales in calendar year 2011, resulting in a change from a Class A/B II liquor licensee to a Class A/B III.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
