

**ORDINANCE NO. 6496**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Schedule VIII (n) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>Name of Street</u>
Division St., south side	Ahrens Ave.	School St.
School St., west side	Division St.	A point 135 feet south
Washington St., north side	Ahrens Ave.	A point 90 feet east

SECTION 2: That Schedule VIII (u) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS be amended to read as follows:

- (u) In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall park a vehicle in any of the following places between the hours of 2:30 p.m. – 3:30 p.m. on school days on the following designated streets:

<u>Name of Street</u>	<u>From</u>	<u>Name of Street</u>
Division St., south side	Ahrens Ave.	School St.
School St., west side	Division St.	A point 135 feet south
Washington St., north side	Ahrens Ave.	A point 90 feet east

SECTION 3: That Schedule VI of the Lombard Traffic Code (Ordinance 1186) entitled ONE-WAY STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>Direction of Traffic Movement</u>
Ahrens St. from Washington Blvd. to Division St. between 8:00 a.m. and 3:00 p.m. On days when public schools are in session	North
School St. from Division St. to Washington Blvd. Between 8:00 a.m. and 3:00 p.m. on school days	South

SECTION 4: That Schedule VI of the Lombard Traffic Code (Ordinance 1186) entitled ONE-WAY STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Direction of Traffic Movement</u>
Ahrens St. from Washington Blvd. to Division St. between 7:30 a.m. and 4:00 p.m. on days when public schools are in session	North
School St. from Division St. to Washington Blvd. Between 7:30 a.m. and 4:00 p.m. on school days	South

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
