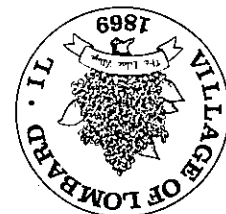

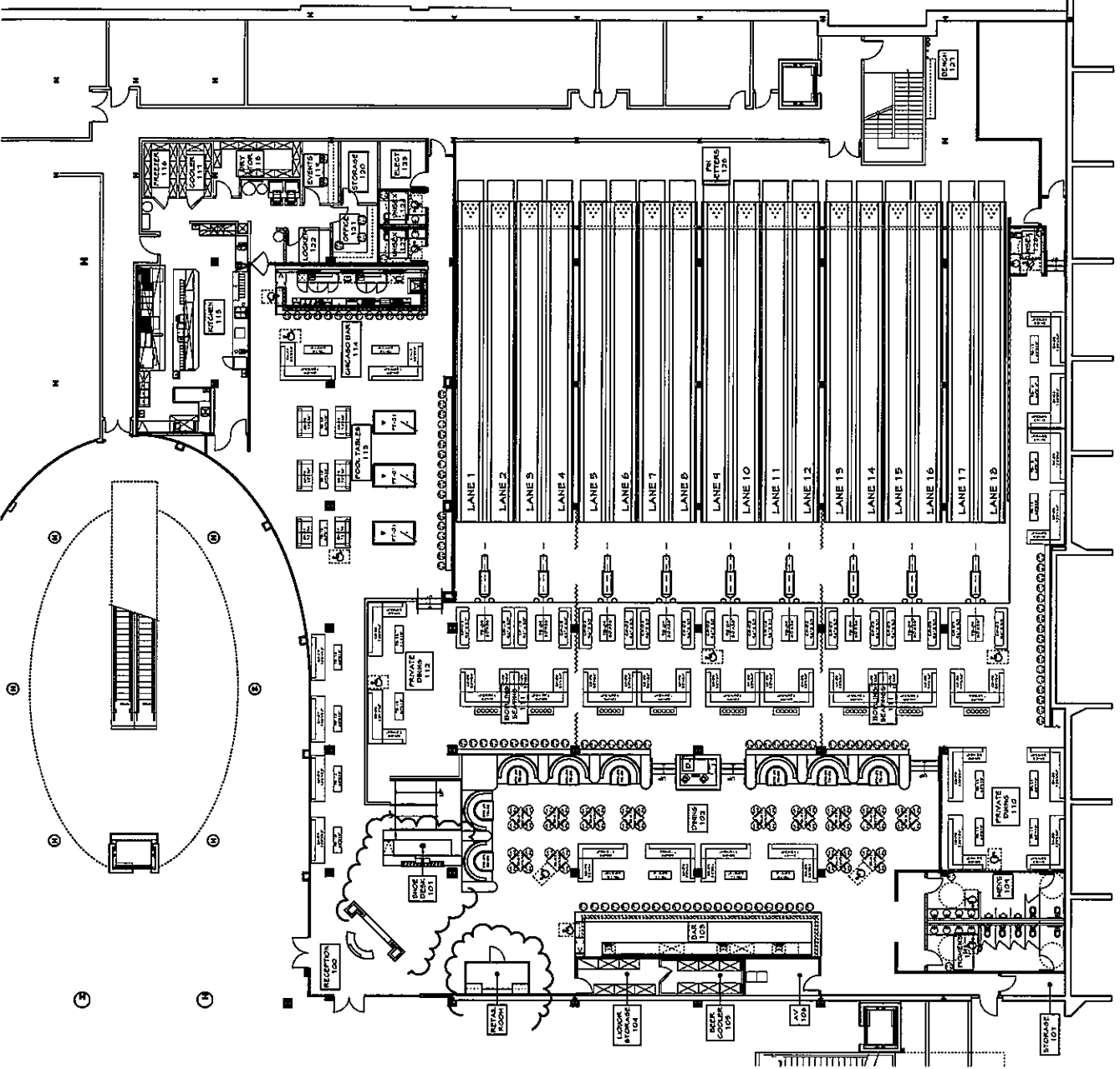
SUBJECT: Request for a Billiard/Pool Hall License

ORDINANCE _____
AN ORDINANCE AMENDING TITLE 11, CHAPTER 110,
SECTION 110.08 OF THE LOMBARD VILLAGE CODE IN
REGARD TO BILLIARDS

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 110, Section 110.08 (E) of the Lombard Village Code is amended to read as follows:

(E) There shall be not more than one (1) billiard/pool hall license issued in the Village of Lombard.

Section 2: That the change in the number of billiard/pool hall licenses set forth in Section 1 above, is a result of granting a billiard license to Lucky Strike Yorktown, LLC doing business as Lucky Strike Lanes located at 100 Yorktown, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
