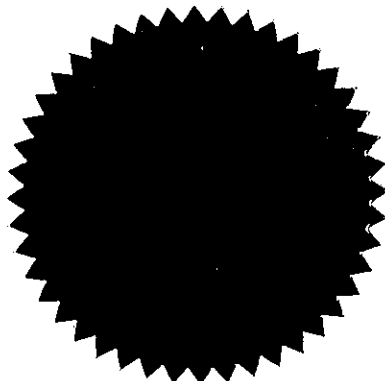

ORDINANCE 5045

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

Name of Street	From	To
Parker Drive, west side	Reskin Road	Kaplan Court
Parker Drive, east side	South edge of Kaplan Court	A point 50 feet south
Reskin Road, north side	Kramer Avenue	Parker Drive
Kramer Avenue, east side	Kaplan Court	Reskin Road
Kaplan Court, south side	Kramer Avenue	Parker Drive
Kaplan Court, south side	East edge of Parker Dr.	A point 50 feet east
Kaplan Court, north side	East edge of Parker Dr.	A point 80 feet east

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.






