**ORDINANCE 4548**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES**  
**OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

**Section 1:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 2

This decrease in Class "C" liquor licenses reflects the sale of the assets of Omega Restaurant and the termination of the Class "C" liquor license issued to Omega Pancake House Inc. in relation thereto.

**Section 2:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 3

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Omega Restaurant, Ltd. who will be operating the business commonly known as Omega Restaurant, 2300 S. Highland Avenue, Lombard subject to the condition set forth in Section 3 below.

**Section 3:** In the event that Omega Restaurant, Ltd. does not provide the Village with a copy of its fully executed Lease Agreement for the premises known as Omega Restaurant, 2300 S. Highland Avenue, Lombard on or before October 31, 1998, Section 2 of this Ordinance shall become null and void.

**Section 4:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.




