

SUBJECT: **Text Amendment to Title 11, Chapter 121, Section 121.03(A)(2)
Number of Public Passenger Licenses**

Village Code Title 11, Chapter 121, Section 121.03(A) states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

Suburban Yellow Taxi LLC and Citi Suburban Dispatch, Inc. currently hold Taxicab Licenses which allowed them to operate within the Village of Lombard through June 30, 2016. Since that time, Suburban Yellow Taxi LLC and City Suburban Dispatch, Inc. have not paid the \$250 renewal fee for the July 1, 2016 through June 30, 2017 licensing period. Staff contacted the owners of both taxicab companies and was informed that they voluntarily would not be renewing their licenses.

Attached is an ordinance amending Title 11, Chapter 121, Section 121.03(A)(2) decreasing the number of Public Passenger Licenses from thirteen to eleven to reflect the non-renewal of the aforementioned licenses.

Staff is requesting a waiver of first reading in order to reflect the correct number of public passenger licenses.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03(A)(2) OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03(A)(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be eleven (11) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the non-renewal of the license by Suburban Yellow Taxi LLC located at 216 Washington St., #1, Naperville, IL and Citi-Suburban Dispatch, Inc. located at 17W695 Butterfield Road, Oakbrook Terrace, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
