ORDINANCE NO. 6203

AN ORDINANCE AMENDING TITLE 7, CHAPTER 73 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE ADMINISTRATIVE ADJUDICATION OF VEHICULAR REGULATION VIOLATIONS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 7, Chapter 73, Section 73.02(A)(7) of the Lombard Village Code is amended to read in its entirety as follows:

"(7) Certify to the Chief of Police the eligibility for immobilization of any motor vehicle whose owner, notwithstanding any other provision in this Code, has accumulated three (3) or more unpaid final determinations of liability under this Chapter."

SECTION 2: That Title 7, Chapter 73, Section 73.02(C)(7) of the Lombard Village Code is amended to read in its entirety as follows:

"(7) Issue certified notices to the Chief of Police regarding persons who have received three (3) or more final determinations of liability which remain unpaid."

SECTION 3: That Title 7, Chapter 73, Section 73.05(C)(4) of the Lombard Village Code is amended to read in its entirety as follows:

"(4) A warning that if three (3) or more unpaid final determinations of vehicular regulation violation liability are outstanding, the Chief of Police will be informed of the vehicle's eligibility for immobilization."

SECTION 4: That Title 7, Chapter 73, Section 73.09(E) of the Lombard Village Code is amended to read in its entirety as follows:

"(E) Notwithstanding payment of any of the aforesaid penalties and fines, any vehicle found to have three (3) or more unpaid final determinations of vehicular regulation violation liability, or three (3) or more unpaid final determinations of vehicular regulation violation liability which have been adjudicated as judgments by the Circuit Court, shall be eligible for immobilization under the provisions of Chapter 72 of this Code."
