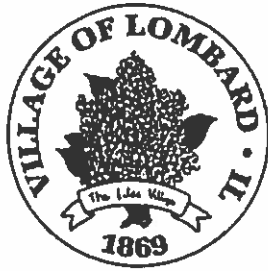
**Subject:** Snow and Debris Hauling Contract Renewal '

The Village of Lombard's current Snow and Debris Hauling contract is set to expire December 31, 2017. We have valued the level of service and commitment Nagel Trucking has provided to the Village of Lombard over the past year. The Village would like to exercise the option of extending the contract for an additional year under the current contract terms and conditions as specified in Contract document PWO-1503. The extension would be in effect from 12:01a.m. January 1, 2018 until 12:00 midnight, December 31, 2018.
