ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "H" liquor license, contained therein to read as follows:

Class "H" - 2

This decrease in Class "H" liquor licenses reflects the change in ownership of Lombard CVS LLC d/b/a CVS/Pharmacy #2791 located at 1005 E. Roosevelt Rd., Lombard and North Grace Lombard CVS, LLC d/b/a CVS/Pharmacy #6497 located at 350 E. North Ave. and the termination of the Class "H" liquor licenses issued to said licensees in relation thereto.

**SECTION 2:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "H" liquor license, contained therein to read as follows:

Class "H" - 4

This increase in Class "H" liquor licenses reflects the issuance of Class "H" liquor licenses to Highland Park CVS, LLC relative to the businesses commonly known as CVS/Pharmacy #2791 located at 1005 E. Roosevelt Road, Lombard and CVS/Pharmacy #6497 located at 350 E. North Ave., Lombard.

**SECTION 3:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
