BACKGROUND/POLICY IMPLICATIONS:

The Department of Community Development transmits for your consideration a request for a plat of dedication for Cortland Avenue right-of-way.

The plat of right-of-way dedication pertains to three Village owned parcels located at the northern termini of Main Street and DuPage Avenue. The proposed dedication would change the status of the parcel from Village owned real estate to the Cortland Avenue publicly dedicated right-of-way. No physical improvements are proposed on the subject properties as part of this action.

Staff recommends approval of the attached Resolution and Plat of Dedication.

SUBJECT: **Cortland Avenue Right-of-Way- Dedication**

Staff is bringing forward a plat of right-of-way dedication for three Village owned parcels located at the northern termini of Main Street and DuPage Avenue for Village Board consideration. The proposed dedication would change the status of the parcel from Village owned real estate to the Cortland Avenue publicly dedicated right-of-way. No physical improvements are proposed on the subject properties as part of this action.

BACKGROUND

In 1990, the Village undertook a feasibility study for a connector roadway between Main Street and DuPage Avenue in the Lombard Industrial Park. The study's purpose was to select an alignment and costs to construct a connecting roadway. The Illinois Department of Transportation (IDOT) indicated the necessity for this roadway in order to widen North Avenue and eliminate the existing frontage road between Main Street and Lombard Avenue. The proposed median for North Avenue would only provide access at Main Street and Lombard Avenue with right turns only. At the time there was a connector roadway between Ridge Avenue and Lombard Avenue but not between Main Street and DuPage Avenue. All alternatives were studied. Improving circulation within the Industrial District and North Avenue was the collective goal with the chosen configuration represented in the attached documents.

In 1994-1996, the three parcels (03-31-402-037, 03-31-402-038 and 03-31-402-041) for the Cortland Avenue connector roadway project were acquired by the Village. The existing Cortland Avenue street was constructed, but the land was not formally dedicated as a public right-of-way upon its construction completion, similar to other streets in the Village. To perfect the intention of the past Village actions and given that the subject properties would not be utilized for any other public purpose than public rights-of-way, a Plat of Dedication was prepared for Village Board consideration.

WHEREAS, the Village does not have a need for subject properties other than to meet the transportation needs of the Village.

WHEREAS, the Corporate Authorities deem it to be in the best interest of the Village of Lombard to approve and accept said plat of dedication;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the plat of dedication attached hereto as Exhibit A is hereby approved and accepted on behalf of the Village of Lombard.

SECTION 2: That the Village President and Village Clerk are hereby authorized to sign said plat of dedication on behalf of the Village of Lombard.
