**Subject:** September 2014 Meeting Item 2—Highland/St. Charles Restricted Turning Movement

In July 2014, the Police Works Department received a petition to adjust the No Left Turn restriction to 7-9 a.m. from Maple and 4-7 p.m. from St. Charles. The current restriction is 7-10 a.m. and 4-8 p.m. The petition has 24 entries, and the segment has 50 properties listed in the Village mapping system. Traffic counts were performed from July 22 through July 24 to determine the traffic volume timing. The results are below:

The restriction prohibits traffic from using Highland as a bypass for Westmore-Meyers during peak hours. Since the average number of vehicles stays constant or decreases and the residents petitioned for the restriction reduction, Village staff would allow the restriction adjustment.

In review, Village staff recommends approval for the above request.

We ask that the Village of Lombard adjust the No Left Turn signs to 7am-9am off Maple and 4pm-7pm off St. Charles.
