Village Board Room ADA Enhancement Project

The Village of Lombard was awarded a Community Development Block Grant (CDBG) for the Village Board Room ADA Enhancement Project. The Village received funding in the amount of \$48,618, which was 50% of the proposed budget for the project. The remaining 50% of the project was funded through Capital Projects Fund. The project objective is to improve the accessibility of the Village Hall Board Room. To accomplish this objective, the following work will be conducted under this project:

- Removal and replacement of dais to meet ADA standards
- Construction of ramp on south wall of room to dais
- Removal of wall behind staff table
- Relocation of speaker's podium, recording secretary's desk and presentation desk
- Creation of four (4) accessible seating areas
- Replacement of door on southeast wall with a new power actuated door and exterior refuge area
- Installation of power actuated units for the main entrance doors to the Board Room
- Replacement of carpeting
- Installation of technology amenities on dais to facilitate paperless meetings

The Village advertised for bids on June 22, 2011 in the *Lombardian*; however no bids were received on July 15, 2011. The Village then solicited bids from six (6) minority business enterprises and women's business enterprises (MBE/WBE) firms that were identified by the DuPage County Community Development Commission. The Village received one proposal from J-Mac Associates Ltd. out of Carol Stream. It is estimated that the project will take approximately five (5) weeks.

The Public Works recommends awarding this contract to J-Mac Associates Ltd. in the amount of \$94,183. The Village budgeted \$97,000 for this project.

This item was tabled from the September 15, 2011 due to approvals being delayed from HUD. The Village has received approval to move forward with the project.

I respectfully request that this item be presented to the President and Board of Trustees at the December 1, 20011 meeting for consideration.

SCOPE OF WORK

Included Items:

- 1. (1) dumpster for construction debris.
- 2. Protection of surroundings to remain.
- 3. Demolition of carpet, millwork walls and desks.
- 4. Removal of bolt down folding chairs as shown on drawing.
- 5. Construction of raised wood platform using all fire treated lumber.
- 6. Removal and replacement of exterior steel door and frame.
- 7. Installation of new door, frame and panic hardware.
- 8. Excavation of exterior planting bed to install additional concrete landing.
- 9. Modification to existing railing at stairs and landing.
- 10. Concrete saw cut approximately 10' long by 6" wide for new electrical conduit installed by owner.
- 11. Concrete patching and skimming as needed for new flooring.
- 12. Installation of automatic double door opener and (2) push paddles. Wired by owner.
- 13. Installation of medium grade, looped, direct glue down carpet.
- 14. Fabrication and installation of new millwork half height walls and cap.

- 18. Painting of the new door and frame and the modified railing only.

- 21. Carpet material cost has been figured as medium grade, samples will be provided for review.
- 22. Carpet pricing is valid if ordered before September 30th, 2011
- 23. A bid deposit 5% and performance bond.
- 24. Rework A/V cabling per progressive communications.

- 2. Electrical, phone & data, mechanical, plumbing, fire protection, and/or roofing work of any kind.
