The Village of Lombard's in-house paving program is conducted using Village owned equipment and rented equipment. Once paving commences and the equipment has been rented, unexpected delays in getting materials can be costly in additional days of rental charges. K-5, d.b.a. DuPage Materials Company has submitted the lowest cost per ton for surface material.

Three area asphalt companies have provided quotes for binder and surface asphalt.
