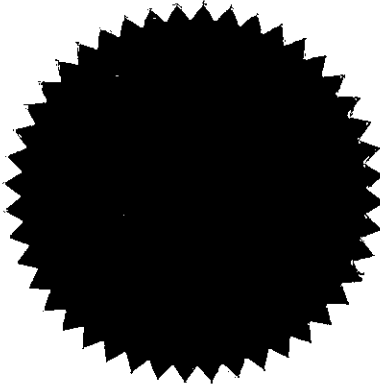

ORDINANCE AMENDING TITLE 5, CHAPTERS 50 AND 51
VILLAGE'S SANITARY SEWER AND WATER SYSTEMS

PAMPHLET

ORDINANCE 5257

AN ORDINANCE AMENDING TITLE 5, CHAPTERS 50 AND 51 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE VILLAGE'S SANITARY SEWER AND WATER SYSTEMS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 5, Chapter 50, Sections 50.100(A), (B) and (C) of the Lombard Village

Code are amended to read in their entirety as follows:

“(A) Within the corporate limits of the Village the charge shall be:

Sewer connection \$2100.00

Water connection \$1350.00

(B) Outside of the corporate limits of the Village, but having been assessed or taxed for sewer and water by the Village, the charge shall be:

Sewer connection \$2100.00

Water connection \$1350.00

(C)

The connection charges for a multiple-family residential use, inside and outside of the corporate limits of the Village, shall include, in addition to the charges per building on property as specified in subsections (A) and (B) above:

Sewer charge for each additional residential unit

per building \$1050.00

Water charge for each additional residential unit

per building \$ 675.00”

SECTION 2: That Title 5, Chapter 51, Section 51.05 of the Lombard Village Code is amended

by revising the first sentence thereof to read in its entirety as follows:

“All pipe and fittings for all taps, together with all labor necessary for their installation between the water main and the buffalo box shall be provided by the property owner”

SECTION 3: That Title 5, Chapter 51, Section 51.25(1)(1)(a) of the Lombard Village Code is

amended to read in its entirety as follows:

“(a) Initial administration fee: \$40.00”

SECTION 4: That Title 5, Chapter 51, Section 51.25(1)(2)(a) of the Lombard Village Code is

amended to read in its entirety as follows:

“(a) Initial administration fee: \$40.00”

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage,

approval and publication in pamphlet form as provided by law.






