Subject: Mowing and Weed control Contract Renewal

On October 20^{th,} 2022, the Village of Lombard advertised for bids for the Village contract **PWO 23-17A**, *Grass Mowing and Weed Control*. The lowest responsible bid was received from *Beary Landscape Management*. The original contract was from March 2023 through November 30, 2023 with two optional one-year extensions.

Staff has contacted *Beary Landscape Management* and they have agreed to accept the year two renewal option at the prices agreed to in October 2023 for the 2024 calendar year. *Beary Landscape Management* provided good service to the Village over the past several years and responded in a timely manner when there have been areas of concern.

Staff recommends renewing the Grass and Weed Mowing contract with *Beary Landscape Management* for the amount of \$73,840.00. This is the first of two possible one-year extensions of the contract and will expire December 31, 2024. Please present this item to the Board of Trustees at the November 2, 2023 meeting for their approval.
