ADDENDUM AGREEMENT

This ADDENDUM AGREEEMENT entered into this __day of _____, 20____A.D, by and between the STATE OF ILLINOIS, acting by and through its DEPARTMENT OF TRANSPORTATION hereinafter called the STATE, and the VILLAGE OF LOMBARD, of the State of Illinois, hereinafter called the VILLAGE.

WITNESSETH:

WHEREAS, the STATE and the VILLAGE entered into an Agreement executed on the 17th day of January, 2013 A.D., for the improvement of IL 38 (Roosevelt Rd), IL 56 (Butterfield Rd) and IL 64 at various to be known as State Section: 2012-070I TS, State Contract: 60V80; and

WHEREAS, it has been determined the VILLAGE has a proportionate share of approach leg jurisdiction at IL 53 at St. Charles Road and at IL 38 (Roosevelt Rd) at Main Street traffic signal of to be modernized as part of this contract; and,

WHEREAS, the aforementioned agreement did not include a provision for these intersections of the VILLAGE jurisdiction of the east leg of St. Charles Road, north and south legs of Main Street, and

WHEREAS, the STATE and the VILLAGE are desirous updating the aforementioned agreement; and,

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:
