Village Hall ADA Accessibility Improvements

The Village applied for and received Community Development Block Grant funding in the amount of \$22,000 for ADA improvements to six (6) washroom facilities located in the Village Hall. The project was included in the FY 2012 CIP in the total amount of \$44,000. In accordance with CDBG guidelines, the plans and specifications were approved by the Community Development Committee at DuPage County prior to the Village seeking bids for the project. The Notice to Bidders was posted in the April 4, 2012 *Lombardian* and sent to six (6) firms designated by the County as MBE/WBE.

Three (3) potential bidders and subcontractors received bid documents. Public Works - received and read one (1) bid at 9:30 A.M. on April 27, 2012. The bid results are summarized below:

M Construction	\$61,294.35
Budget Estimate	\$44,000.00

As a result of receiving only one bid that greatly exceeded the Village's budget, staff is of the opinion that the Village Board should reject all bids at this time. Staff has discussed the bid process and lack of interest with County staff and sought approval to utilize the solicitation of proposal method of procurement rather than the formal bid process. Staff at the County concurred with the requested process change and Lombard staff has submitted revised plans and specifications to the County for review and approval by the County. Once County staff approves the plans and specifications, the Village will solicit proposals for the project from qualified contractors. Staff anticipates that a recommendation for a contract will be placed on the Village Board agenda for June 21, 2012 meeting.

Staff is recommending that the Board reject all bids and have staff solicit proposals for the project.
