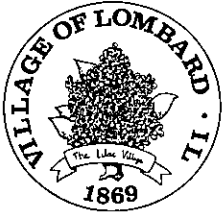

Attached please find a contract and resolution pertaining to the resident engineering services for North East Lombard Area Improvements.

This selection was made from the Resident Engineering Short List. The short list is comprised of six firms. All six firms responded to the request for proposal. Upon review, it was determined that K Plus Engineering, Ltd. of Naperville is the most qualified firm to serve as resident engineer.

K Plus Engineering is new to the short list and has not preformed any services directly for the Village. However, the Resident Engineer (Mr. Tom Gill) and the Senior Technician (Mr. Mike Daniels) have worked on Village of Lombard projects in the past with other engineering firms.

The scope and fee were negotiated with K Plus and agreed to by both parties. The not-to-exceed fee for resident engineering services is \$217,109.30.

Please present this agreement and resolution to the President and Board of Trustees for their review at their regular meeting of April 6, 2006. If approved, please return one original signed copy returned to Public Works-Engineering for further processing.
