
- Southeast corner of Main Street and Wilson Avenue

**BACKGROUND**

The Garden Club has recently submitted a request to place several temporary signs on Village owned property. The requested locations include:

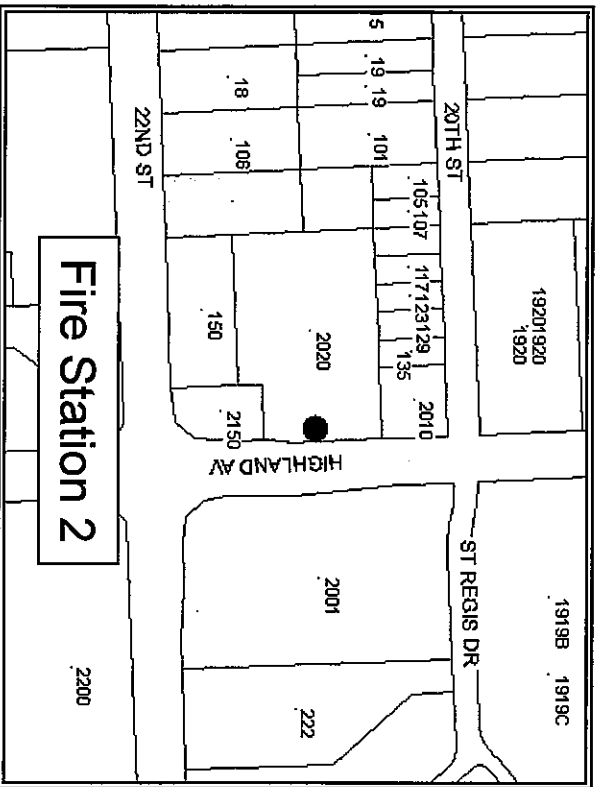
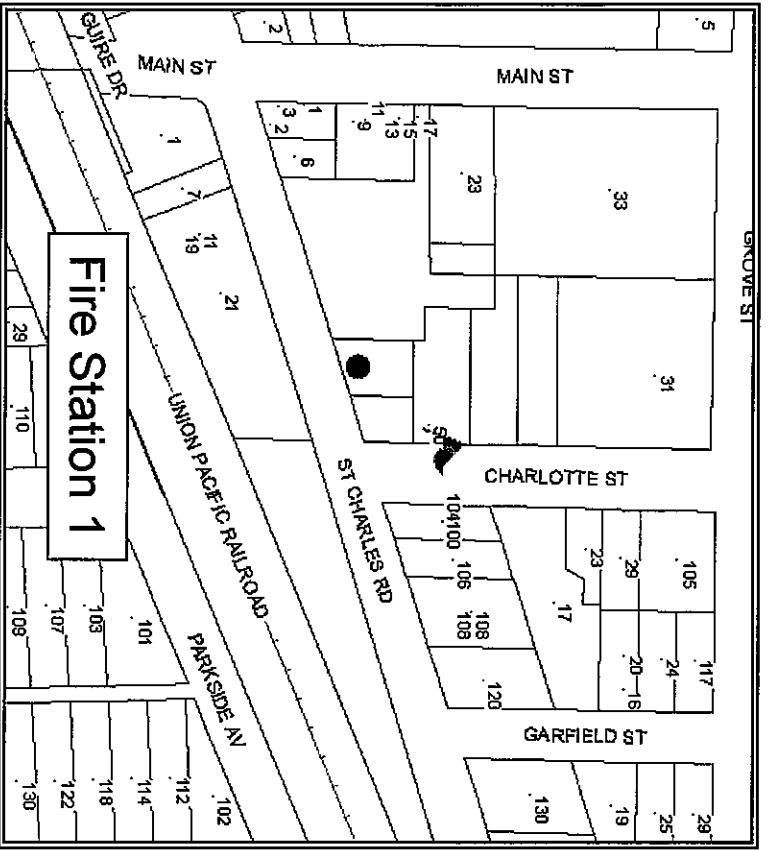
- Southeast corner of Main Street and Wilson Avenue
- In front of Fire Station 1 at 50 E St. Charles Road
- In front of Fire Station 2 at 2020 S Highland Avenue

The Village Board has approved similar requests for the Jaycees Haunted House and LTC's Spooktacular signs.

The sign is intended to promote their "Prairie Days" which will be held on September 26, 2010 at Terrace View Park. The temporary signs would be 4' x 8' and provide the name, date and location of the event. They are requesting the sign to be put up September 16, 2010 and be removed after September 26, 2010.
