Public Works received three sealed bids for a replacement truck with trade-in. Tom Peck Ford had the lowest net price. The price for the new 4x4 pickup truck with plow is \$36,486.35 minus a trade-in allowance of \$20,000 equals a net price of \$16,486.35. The budgeted amount in reserve for this purchase is \$26,000.
