**SUBJECT: Request for a Class "XX-VG" Liquor License – Brauer House
1000 N. Rohlwing Road #13**

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

SBBL LLC d/b/a Brauer House located at 1000 N. Rohlwing Road #13 currently holds a Class "XX" liquor license which allows the sale of alcoholic beverages with the primary purpose of the establishment being a restaurant and live entertainment venue with a full-service kitchen.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. SBBL LLC d/b/a Brauer House has decided to voluntarily not renew their Class "XX" license for the upcoming liquor licensing term and SBBL LLC d/b/a Brauer House applied for a new Class "XX-VG" liquor license.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class "XX" liquor license category by one and increasing the number of entries in the Class "XX-VG" license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "XX" liquor license, contained therein, to read as follows:

Class "XX" - 0

This decrease in the number of Class "XX" liquor licenses reflects the voluntary non-renewal of SBBL LLC d/b/a Brauer House located at 1000 N. Rohlwing Road #13 for the July 1 through December 31, 2019 licensing term and the termination of the Class "XX" liquor license issued to SBBL LLC in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "XX-VG" liquor license, contained therein, to read as follows:

Class "XX-VG" - 1

This increase in the number of Class "XX-VG" liquor licenses reflects the issuance of a new Class "XX-VG" liquor license to SBBL LLC d/b/a Brauer House located at 1000 N. Rohlwing Road #13, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
