

ORDINANCE NO. 6566

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (two hours between the hours of 8:00 am and 6:00 pm) be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Westmore Ave. Both sides right-of-way	Division St.	South property line of the Prairie Path

Section 2: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (two hours between the hours of 8:00 am and 6:00 pm) be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Westmore-Meyer Rd., East side, right-of-way	Division St.	South property line of the Prairie Path
Westmore-Meyer Rd., West side, right-of-way	A point 65 feet north of the Division St. northern Right-of-way	South property line of the Prairie Path

Section 3: That Schedule X (h) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (for a period not to exceed ten minutes) be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Westmore-Meyer Rd., West side, right-of-way	Division St. northern right-of-way	A point 65 feet north of the Division St. Northern right-of-way

Section 4: That Schedule XXI (a) of the Lombard Traffic Code (Ordinance 1186) entitled NO MINIVAN, VAN, TRUCK OR RECREATIONAL VEHICLE PARKING ON PREFERENTIAL STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Westmore-Meyers Rd. West side	North curb line of Division St.	A point 130 feet north

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


