Staff is requesting a waiver of first reading in order to accommodate their closing.

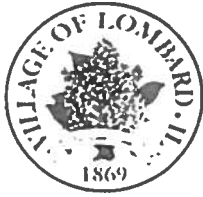

SUBJECT: **Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code
Embassy Suites Lombard & Discovery Bay – 707 E. Butterfield Rd**

Embassy Suites Hotel and Discovery Bay Restaurant, located at 707 E. Butterfield Road, currently hold liquor licenses. Embassy Suites Hotel currently holds a Class “O” liquor license which allows consumption of alcoholic beverages on the premises of a hotel. Discovery Bay currently holds a Class “A/B-II” liquor license which allows the service of alcoholic beverages served as an adjunct to food service with no packaged sales allowed.

Staff has been notified that the existing corporate ownership of both licensed entities will change due to the sale of the hotel. Attached are two ordinances, one for Embassy Suites Lombard and one for Discovery Bay, reflecting the change of ownership.

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class O" liquor license, contained therein, to read as follows:

Class "O" - 2

This decrease in the number of Class "O" liquor licenses reflects the termination of the Class "O" liquor license issued to FelCor Lombard Lessee, LLC d/b/a Embassy Suites Hotel, located at 707 E. Butterfield Road, due to new ownership of the hotel.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "O" liquor license, contained therein, to read as follows:

Class "O" - 3
