ORDINANCE _____AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN ____REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows effective April 1, 2004:

Class "F" - 3

This decrease in Class "F" liquor licenses reflects the sale of the assets of Pioneer Hills, LLC d/b/a S&R Drugs and the termination of the Class "F" liquor license issued to Pioneer Hills, LLC in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows:

Class "F" - 4

This increase in Class "F" liquor licenses reflects the issuance of a Class "F" liquor license to Nimani, LLC who will be operating the business commonly known as S&R Drugs located at 338 S. Main Street, Lombard.
