Fees for Approving & Recording Plats of Easement & Vacation

Please find the attached amendment to Chapter 36.21(J)(1) pertaining to fees associated with approving and recording plats of easement dedication, abrogation and vacation.

BACKGROUND

Existing Village Code established a fee schedule associated with the review and approval of plats of annexation, subdivision and resubdivisions. However, current Village Code is silent with respect to fees associated with other types of plats commonly reviewed and approved by staff and the Village Board.

For developments subject to an annexation or a development agreement, plat fees can be considered reimbursable expenses. However, absent an agreement, the approval and recording costs for plats of dedication, abrogation and right-of-way vacation would be borne by the Village. The proposed amendment will establish reasonable approval and recording fees in a similar manner. The proposed fees schedule will be the same as administrative plats of subdivision (i.e., \$150.00 for the first page, \$50.00 for each additional page).

RECOMMENDATION

Staff recommends approval of the attached Ordinance with a waiver of first reading.

AN ORDINANCE AMENDING TITLE 3, CHAPTER 36, SECTION 36.21 (J)(1) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE FEE SCHEDULE RELATIVE TO CERTAIN SUBDIVISION RELATED PETITIONS AND APPLICATIONS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Title 3, Chapter 36, Section 36.21(J)(1) of the Lombard Village Code be amended to read in its entirety as follows:

§ 36.21 FEE SCHEDULE.

- (J) Fees for filing plats, for engineering plan review and public improvement inspection shall be as follows:
- (1) Any filing and review of Plats of Subdivision, including Plats of Subdivision, Resubdivision, or Consolidation, <u>Easement Dedication</u>, <u>Easement Abrogation or Vacation of a Public Right-of-Way</u>, shall be subject to the following fees:
- a. All Administrative Plats of Subdivision and Plats of Consolidation for one single-family residence \$125.00 for the first page, plus \$50.00 for each additional page.
- b. All other Administrative Plats of Subdivision and Plats of Consolidation \$150.00 for the first page, \$50.00 for each additional page.
- c. All Minor and Major Plats of Subdivision or Resubdivision (Preliminary or Final) \$300.00 plus \$50.00 per acre or portion thereof.
 - d. All Final Plats (with preliminary plat approval) \$300.00.
- e. <u>Plats of Easement Dedication, Easement Abrogation or Vacation of a Public Right-of-Way \$150.00 for the first page, \$50.00 for each additional page.</u>
